Modern technological tools, strong law enforcement, and public partnership may play an important role in this. Public awareness and youth empowerment can be helpful in crime prevention. Crime can be reduced to a minimum by conducting public awareness campaigns in partnership with the government and law enforcement agencies.

Whenever the anti crime agencies are successful in preventing crime, public trust in them increases. This trust promotes social harmony among people who can live their lives without fear.

#### Islamic method of anti crime control:

First of all, Islam invites man to believe in Allah Almighty and the Hereafter, and offers a system of self-purification, through which no idea of guilt and sin which arise from the heart and mind of man. Then it establishes such a society in which man can fulfill his basic needs and desires through legitimate means and does not have to resort to illegal and criminal means to fulfill these needs. When crimes committed in the first two ways are committed. It is not possible to stop them, then, it is necessary to direct the government machinery to move to stop them. The detail of this matter is that before imposing severe punishments for crimes, Islam, the ruler of the Islamic state, gives the power to distinguish the religion, creed and color of the people. And regardless of race, it orders to provide such resources for them through which they can get food, clothing, house and education so that they cannot adopt illegal resources after fulfilling their legitimate requirements. Apart from this, Islam holds the government responsible for ensuring that wealth does not end up in the hands of a few people. That's why Islam, keeping in view the human nature, has emphasized on giving a complete code of life as well as establishing a social system in which there is no scope for committing crimes. Even so, if a person commits a crime, to keep the society safe from degradation and immorality, Islam has rightly prescribed exemplary fixed punishments so that seeing these notified punishments, other people will never follow the path of sin.

### Prevention of crimes in the light of Quran:

For the prevention of crimes, there are several rules and regulations in the Holy Quran which provide guidance for making the Islamic society as well as the whole world safe and fair. These principles include moral rebuke, social justice, penal laws, and social welfare practices. Here are the Islamic methods of preventing crimes mentioned along with the Qur'an and their references:

### Learning piety and fear of God:

The most prominent principle in the Qur'an is to promote piety and fear of Allah. When a person has the fear of God in his heart, he tries to avoid evil and sin. Allah Almighty says in the Holy Qur'an thus:

"O believers! Fear Allah and speak the truth. "<sup>1</sup>

Undoubtedly, piety prevents a person from doing any type of bad deeds and makes him righteous. Attracts towards piety, thereby it is possible to control crime.

### **Ruler of Justice:**

In Qur'an, justice is considered as the fundamental principle for the social stability. When there is justice in the society, the tendency of crime will ultimately less. It is stated in the Qur'an:

"Indeed, Allah commands justice, kindness and giving to relatives and forbids indecency and all evil and cruelty. He admonishes you so that you may get the real purpose of advice. "<sup>2</sup>

No doubt, the prescribed verse describes justice as a means of eliminating evil and oppression, which is necessary for the prevention of social crimes.

### To protect the innocent and to prevent accusations:

The Qur'an enjoins us to avoid accusations and false slanders in order to save the innocent. Allah says:

"And those who persecutes in believing men and women without any crime they have committed have borne the burden of slander and manifest sin."<sup>3</sup>

In this verse there ,man is a encouraged to avoid false accusations and to do justice.

### Prevention of obscenity and lewdness:

In the Qur'an, it is ordered to avoid obscenity and immorality, because these practices cause crimes and social deterioration. In this regard, Allah says thus:

"And do not go to the indecencies that are apparent among them or those that are hidden and do not kill unjustly the soul whose life Allah has made sacred. It is commanded you to have wisdom"<sup>4</sup>

The order warns people to stay away from obscenity, no doubt, which is an important crime prevention tool.

### Prevention of murder and riot:

In the Qur'an, the killing of an innocent person is considered as the killing of the entire humanity, which is the basis of social peace. It is command of Allah as the one who killed someone not for the sake of a life or for mischief; it is as if he killed all the people in the world. Similarly, the one who gave life to someone; it is as if he gave life to all the human beings.

The Qur'an emphasizes the prevention of murder and corruption, which is very helpful in reducing social crime.

#### Protection of rights of women and weaker social class:

The Qur'an enjoins the protection of the rights of women and socially weaker persons so that they are not oppressed and depressed. Allah says thus:

"Live well with women."<sup>5</sup>

Through this order, social justice is promoted; it will be helpful to reduce crimes against the oppressed class.

#### Learning about social welfare and well-being:

In the Qur'an, people have been encouraged to do goodness and sapphire and forbade from doing evil. Allah says:

"And among you there must be such a group that calls to good, enjoins righteousness and forbids from doing evil, and those are successful."<sup>6</sup>

Through this prescribed verse, it is ordered to prevent evil at the social level and to promote the works of virtue, which is an important means of crime control.

### **Brief Summary:**

In eliminating crimes, there are comprehensive guidelines for the prevention of crimes in the Holy Qur'an, which promotes social peace, justice, and the protection of human rights. Fear of Allah, piety, social justice, welfare measures, and penal laws, which are very effective principles of Islamic society.

#### Prevention of crimes in the era of the Prophet (PBUH):

No doubt, the era of the Prophet (PBUH) was to establish a comprehensive Islamic system for the prevention of crimes, with the aim of social peace, justice, and the protection of human rights. Some peculiar principles and measures for crime prevention were adopted during this period, including moral education, accountability, penal laws, and improving social order. This system of the Prophet (PBUH) can be understood easily through the study Islamic Shariah.

#### **Importance of Eyewitnesses and Testimony:**

In Islam, the presence of witnesses is necessary to prove the crime. If there are witnesses in a case, their testimony is given priority. Hazrat Muhammad (PBUH) said:

"It is narrated from Hazrat Fatimah bint e Qays, may Allah be pleased with her, that when my husband divorced me, I intended to leave this place, so I came to serve the Holy Prophet (PBUH). The Prophet (PBUH) said that you should go to the house of your cousin Hazrat Amer bin Makhtoum and you should spend the period of time in that place. After hearing this, Hazrat Aswad threw a stone at him

asking why you are giving this kind of fatwa. Then Hazrat Umer said that if you present two witnesses to this blessed decree of the Holy Prophet (PBUH), then it is fine, otherwise we cannot leave the Book of Allah because of a woman, and that verse is this: Do not take them out of the house and they do not leave the houses themselves. However, if they commit a clearly bad act, they should be expelled from the houses."<sup>7</sup>

This principle facilitates the delivery of social justice and does not convict anyone on the mere accusation. To prove a right, the testimony of two persons is mandatory.

### Not Relying on Confession:

It is not considered right to compel someone to accept guilt through investigation. In the time of the Prophet (PBUH), even if a person had accepted a crime, it would be verified and only after confirmation, someone would be punished. Hazrat Muhammad (PBUH) said:

"A wrestler is not one who is too harsh in revenge, but a

strong one who controls himself when angry."<sup>8</sup>

It means we should cover up crimes until clear evidence is not found. Hence, it is clear from this hadith that it is against Islamic principles to declare someone guilty before proving the crime.

#### **Tendency to acquit:**

In Islamic investigation, the benefit of doubt is always given to the accused. Hazrat Muhammad (PBUH) said:

"He is not a liar who reconciles people and speaks better things."<sup>9</sup>

It is very clear from this Islamic principle that it is against Islamic procedure to convict any person without evidence during investigation.

### The principle of gentleness and mercy:

In the ways of Islamic interpretation, instead of strictness, it has been instructed to adopt an attitude of mercy and gentleness. Hazrat Muhammad (PBUH) said:

"Allah will not show mercy to the person who does not

show mercy to other".<sup>10</sup>

As harshness and violence in the interrogation process may not prove fruitful. So, it is important to treat the accused gently so that he gives correct information.

#### To be a seeker of truth:

The most important thing among Islamic comprehensive principles is to search for truth and facts. Hazrat Muhammad (PBUH) said:

"Give good news, not create hatred. Create ease, not difficulties and complexities. ""<sup>11</sup>

This means that during the investigation the truth should be given importance and any false accusation must be avoided.

### Propensity to forgive and willingness to reform:

In crime prevention forgiveness and reform were also given importance. If a person repents on a crime and is ashamed of his actions, there is also scope for forgiveness according to Islam. Hazrat Muhammad (PBUH) said thus:

"Beware of temptations, for in such cases the tongue plays a worse role than the sword."<sup>12</sup>

During the time of the Prophet (PBUH), there was a trend that if someone confessed to the crime and no harm was done to him, and then the accused was often forgiven, so that he would refrain from doing these actions again.

No doubt, it has been cleared from this hadith that Allah wants to forgive the human beings in society.

#### Discouragement of evil and promotion of good:

In the reign of the Prophet (PBUH), evil was discouraged at the social level along with the good deeds were encouraged. Hazrat Muhammad (PBUH) said:

" If you see any evil with in front of you, stop it with your hand, if you cannot afford it, stop it with your tongue, and if you cannot afford it, then do it with your heart, and this is the weakest level of faith."<sup>13</sup>

During the Prophet (PBUH) era, the Islamic procedure of investigation proved an ideal system of justice in which no one was convicted without evidence. It included the importance of witnesses, evidence, and testimony, along with the principles of leniency, forgiveness, justice, honesty, accountability, and correction and giving the benefit of the doubt. By adopting these principles of Islamic education social justice can be promoted. Islamic society has given priority to spiritual and social training for the elimination of crimes. A safe, secure and just society was built on the basis of these Islamic prominent principles.

### Anti-crime and advanced investigation requirements:

Today, the nature of crime is changing day by day. The growing incidences of cybercrime, transnational organized crime and terrorism have produced new challenges for police and investigative agencies.

**Preparation and filing of a report:** At the end of the investigation process, a detailed report is prepared that includes all the evidences, findings, and analysis. This report is submitted to the court so that the offender can be convicted.
